ANNEX II

Subject to the limitations set forth herein, the purpose for which the Corporation is organized is to engage solely in the following activities:

- (1) to serve as the sole general of CFP Venture I, L.P., a Delaware special purpose imited partnership (the "Partnership");
- (2) to act as, and exercise all of the authority of, the general partner of the Partnership, including, without limitation:
 - to execute and deliver an Agreement of Limited Partnership for the Partnership dated as of the date hereof, and any and all amendments, supplements, restatements or other modifications thereto, between the Corporation, as sole general partner, and CenterAmerica Property Trust, L.P., a Delaware limited partnership, as limited partner (the "Partnership Agreement");
 - (b) to execute and deliver, on behalf of the Partnership, (i) a loan agreement with Secore Financial Corporation, as the Mezzanine Lender (herein so called) (the "Mezzanine Loan Agreement"), and a promissory note evidencing a loan in the approximate aggregate amount of \$25,000,000 (the "Mezzanine Loan") payable to the order of the Mezzanine Lender (the "Mezzanine Note"); and (ii) any and all assignments, deeds of trust, pledge agreements, financing statements, security agreements and all other agreements, certificates, documents, notices, papers or other writings in connection with such borrowings;
 - (c) to engage in any activities necessary to authorize, execute and deliver any other instrument, agreement, certificate, notice or document in connection with the activities described above, including the filing of any instrument, agreements, certificates, notices, applications and other documents necessary or advisable to comply with any applicable laws, statutes, rules and regulations or necessary or advisable to perfect or protect the above-referenced security interests;
 - (d) to engage in such lawful activities and to exercise such powers permitted to corporations under the laws of the State of Delaware that are necessarily incident to or connected with the foregoing or necessary or convenient to accomplish the foregoing and which are consistent with the limitations set forth in the Certificate of Incorporation of the Corporation; and
 - to take any and all actions necessary under and pursuant to the Partnership Agreement and the Mezzanine Loan Agreement; and
 - (3) to transact any and all lawful business for which the Corporation may be organized under the State of Delaware and the State of Florida that is incident, necessary and appropriate to accomplish the foregoing.
