In response to your letter dated October 25, 1999 (copy enclosed), please remove any fees or penalties related to transaction of business in Florida prior to qualifying in the state.

Cymer, Inc. has not transacted business as a foreign corporation in Florida without authority, prior to qualifying.

The company's activity in Florida consists of two field service engineers who live in Florida and travel to locations outside Florida to service equipment installed at customer worldwide locations. The company does not have a physical location in Florida. All of Cymers's sales are accepted in California.

Cymer contacted the state of Florida in 1997 as to the registration requirements. Based on the company activity, the company was advised to register with the Florida Department of Labor and Employment for withholding purposes, which it did in 1997. The company also determined that it was liable for income tax reporting and filed form F-1120 beginning in 1997.

The company's activity has not changed since the 1997 registration. The purpose of filing for an Authorization to Transact Business in Florida is to protect the company name in the state and provide access to the states legal system.

Based on the above, we request that you remove any penalties and fees imposed by section 607.1502(4) and approve the application for authority to transact business in the state.

COMMENTS: This is to confirm our conversation today wherein we have discussed the issue of foreign non-qualified penalties and annual report fees due from Cymer, Inc.




