We are responding on behalf of the above-named taxpayer in regards to your notice dated February 18, 2000, a copy of which is enclosed. Your notice first advises that the business entity may not serve as its own registered agent and to please re-designate another person. In addition, it assesses a civil penalty of \$1,000 for each year that the taxpayer transacted business prior to its qualification and appropriate fees being paid.

During the year ended 1997, the taxpayer entered into an agreement to purchase the assets of an existing entity. The entity has had minimal activity. The taxpayer's prior accountant did not advise him that an application to transact business in Florida was required, along with the Annual Uniform Business Report. During January 2000, the taxpayer terminated his prior accountant and retained our firm to prepare the corporate filings.


