We are legal counsel to the above-referenced corporation. Enclosed please find a Uniform Business Report ("UBR") form with respect to the corporation for filing, together with a check in the amount of \$158.75 for the filing fee, which includes the cost for a certificate of status.

We are aware that the UBR is filed late and that a \$400 penalty is generally imposed. We respectfully request, however, that the penalty be waived. The corporation was recently incorporated and was not aware of its obligation to file a UBR Report. The corporation did not receive the UBR Form from the Corporation Division prior to May 1, 2001, the filing due date. The Corporation Division did not include the suite number in the address to the Corporation and thus the corporation never received the UBR Form from the Corporation Division. The enclosed UBR includes the correct suite number of the corporation. The corporation was not aware of its duty to file the UBR until it received a subsequent notice (despite the missing suite number) from the Corporations Division indicating that the UBR was overdue.
