
Campsite Evangelism, Inc. recently made application with the State of Florida for authorization for "Foreign Not For Profit Corporation to Conducts Its Affairs in Florida." Per your letter of response dated March 20, 2000, a civil penalty was assessed against our organization for transacting business in Florida prior to qualifying with the State.

We are a small non-profit organization with limited funds and we are not able to pay the assessed penalty of \$22,886.25. However, we do want to be honest and above reproach in this matter. We were not aware of the filing requirement in Florida until we applied for tax exemption status for our organization. We want to assure you that there has been no willful negligence in filing the necessary papers nor have we have intentionally evaded this requirement. We have not been tax exempt since we began doing business in Florida; thus we have paid the appropriate sales taxes and property taxes due the State of Florida and Pasco County for this period of time.

By copy of this letter, we are petitioning the state for consideration of our circumstances and waiver or reduction of this penalty.


