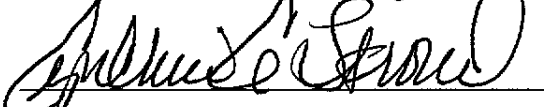
Whereas, Clearwater Services, Inc. is an Idaho corporation in good standing, and it desires to become licensed and registered in the state of Florida.

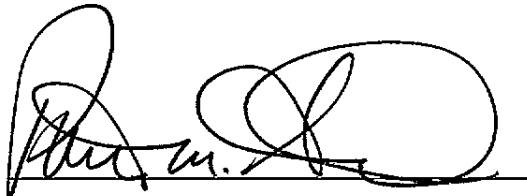
Further, whereas, another corporation already has the name "Clearwater Services". Thereby preventing Clearwater Services, Inc. from using that name in Florida.

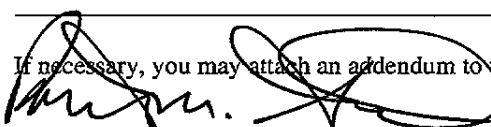
