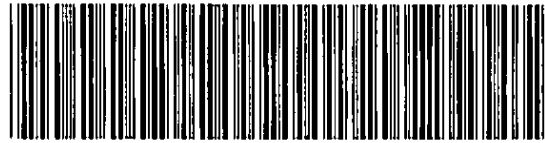

Pursuant to Section 607.1105 of the Florida Business Corporation Act (the "FBCA"), Tutogen Medical, Inc., a Florida corporation ("Tutogen"), in connection with the merger of Tutogen with and into Surgalign Spine Technologies, Inc., a Delaware corporation ("Surgalign"), hereby submits this articles of merger (this "Articles of Merger") for filing and hereby certifies as follows:
