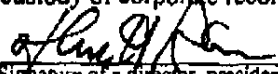

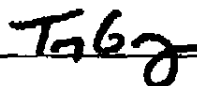

Pursuant to KRS 271B.10-060 and KRS 271B.10-070, the undersigned hereby submits the following Amended Articles of Incorporation of Host Communications, Inc. (the "Corporation"), and states as follows:

FIRST, the name of the Corporation is Host Communications, Inc.

SECOND, the Amended Articles amend Articles I and II (the "Amendment"), the text of which is set forth in the Seventh paragraph below.

THIRD, the Amendment was adopted by the Shareholders of the Corporation on March 31, 2008 in the manner prescribed by the Kentucky Business Corporation Act.

FOURTH, Shareholder action was required to amend the Corporation's Articles of Incorporation.

FIFTH, the designation, number of outstanding shares, number of votes entitled to be cast by each voting group entitled to vote separately on the Amended and Restated Articles set forth herein, and number of votes of each voting group indisputably represented, were as follows:
