In compliance with section 617.1503, Florida Statutes, the following is submitted to register a foreign not for profit corporation ("Corporation") for authorization to conduct its affairs in the State of Florida.

ARTICLE I – NAME

ARTICLE VIII – PURPOSE

The Corporation is requesting authorization to carry out its affairs in the State of Florida for the following purposes:

- (a) To exist and operate solely for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, (the "Code") and no part of the income or assets of the Corporation shall be distributed to, nor inure to the benefit of, any individual;
- (b) To operate without regard to race, age, sex, religion or national origin;
- (c) Without limiting the foregoing, to engage in the following activities:
 - (1) operate a recycling program for medical goods from hospitals and clinics in the United States or foreign countries to be donated to hospitals in impoverished countries;
 - (2) receive distressed goods from corporations or other businesses and forward such goods to impoverished countries;
 - (3) develop and implement the medical goods recycling program for use by other charitable organizations, ministries and churches, including the teaching of seminars to duplicate the program around the world;
 - (4) provide a resource for medical supply needs in impoverished countries;
 - (5) establish and operate a medical education training program with teams of medical professionals presenting training sessions for medical professionals or others in impoverished countries; and
 - (6) operate a Christian ministry with an emphasis in medical missions.
- (d) To carry out its functions such that no substantial part of the Corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office; and
- (e) To operate, participate in and/or manage any other programs or activities that are not prohibited by law and that do not conflict with the provisions of Section 501(c)(3) of the Code.
