
To Whom It May Concern:

Enclosed please find a Corporation Reinstatement form for Reedy Branch Shopping Center, Inc. This corporation was dissolved in Florida on September 19, 2003, for nonfiling of its annual report. When the annual report was mailed out in late 2002, Reedy Branch was represented by a law firm other than our present attorneys, Nossaman, Guthner, Knox & Elliott, LLP. When the corporate records were transferred to the Nossaman firm, neither a completed copy of the annual report nor the blank form was among the documents and minute books.

For the above reason, we request a waiver of the \$175.00 reinstatement fee. The Reinstatement form previously sent to you by the Nossaman firm was returned since you require an officer's signature on this fee waiver request. You are holding the funds from that earlier submission in the amount of \$78.75, representing the nonprofit corporation annual report fee of \$61.25 and \$17.50 for a certified copy of the Reinstatement and a status certificate. We understand there will be no annual report due again until 2004.
