



AMENDMENT TO THE ARTICLES OF INCORPORATION OF WECTEC GLOBAL PROJECT SERVICES INC.

December 12, 2017

WECTEC Global Project Services Inc., (the "Corporation"), a corporation organized and existing under and by virtue of the provisions of the Louisiana Business Corporation Act (the "LBCA"), does hereby certify as follows:

- On July 5, 2000, the Corporation filed the original Articles of Incorporation of the Corporation with the Secretary of the State of Louisiana under the name SWINC Acquisition Three, Inc.
- 2. On July 20, 2000, SWINC Acquisition Three, Inc., changed its name to Stone & Webster, Inc.
- 3. On December 26, 2013, Stone & Webster, Inc. changed its name to CB&l Stone & Webster, Inc.
- 4. On January 20, 2016, CB&I Stone & Webster, Inc. changed its name to WECTEC Global Project Services Inc.
- 5. Article I of the Articles of Incorporation is hereby amended and restated to read as follows:

ARTICLE I: The name of the corporation is Stone & Webster, Inc.

- The number of shares of Corporation stock outstanding is 1,000 shares. The number of shares
 of Corporation stock entitled to vote on the Amendment is 1,000 shares. There is only one
 class of Corporation stock.
- 7. All 1,000 shares of stock of the Corporation voted for the Amendment. No shares voted against the Amendment. The Amendment was approved by the shareholders in the manner required by the LBCA.
- 8. The Amendment does not provide for an exchange, reclassification or cancellation of issued shares.
- 9. The Amendment does not effect a change in the amount of stated capital.

 This Amendment to the Articles of Incorporation shall become effective as of the date of filing.
