<u>FIRST</u>: That the Board of Directors of said Corporation, by the unanimous written consent of its members filed with the minutes of the Board, adopted a resolution proposing and declaring advisable an amendment to the Certificate of Incorporation to change the name of the Corporation to Garda Security Inc.

SECOND: That in lieu of a meeting and vote of stockholders, the sole stockholder of the Corporation has given its ununimous written consent to change the name of the Corporation to Garda Security Inc.
