With regard to the above-referenced matter, we respectfully request the waiver of the civil penalties proposed, due to the extenuating circumstances which have caused this taxpayer's failure to register in a timely fashion.

The taxpayer is a small Canadian corporation, whose president and sole shareholder is Hank Vankesteren. The business being transacted in Florida is the operation of a single charter-fishing boat. As soon as the taxpayer formed the intent to transact business in Florida, upon the advice of the corporation's Canadian accountant, the taxpayer engaged a Florida CPA, Robert Hull, to advise and prepare the necessary authorizations and tax returns. Mr. Vankesteren consulted with Mr. Hull to determine the requirements for doing business, and on a regular and continuing basis to provide him with current financial statements and copies of the timely-filed Canadian tax returns. Mr. Vankesteren obtained occupational licenses from the City of Cape Corat and Lee County, FCC radio operator's license, Federal and State fishing permits, first aid and CER training certificates, and a captain's license. In other words, he obtained every possible authorization, which he was able to determine to be a requirement. When he opened the Ura corporate checking account, he asked Mr. Hull to make application for the Federal identification number. Enclosed, you will find copies of the repeated requests from Mr. Vankesteren to Mr. Hull to prepare and file the necessary Florida and Federal tax returns. You will also find copies of the many responses from Mr. Hull, in which he continually asserted that there were no filing requirements for this foreign corporation. During all of the years in question, Mr. Hull-prepared the U.S. individual income tax returns and the Florida intangible tax returns for Mr. Vankesteren, without incident.

The taxpayer engaged a Certified Public Accountant, licensed by the Florida Department of Professional Regulation, to be certain that all official requirements were met. He brought every piece of official correspondence to that Accountant. He made every possible effort to ascertain and comply with all of the regulations. His only fault in this matter lay in relying upon what ought to have been competent, professional advice. The taxpayer encloses herewith a check in the amount of \$815 to cover the annual report/uniform business report fees, and most urgently requests waiver of the proposed penalties.
