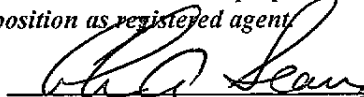

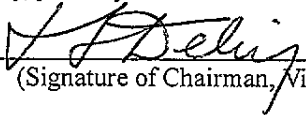

That on the **21st day of August, 1998**, **NILED, INC.** became incorporated under the laws of the State of California by filing its Articles of Incorporation in this office; and

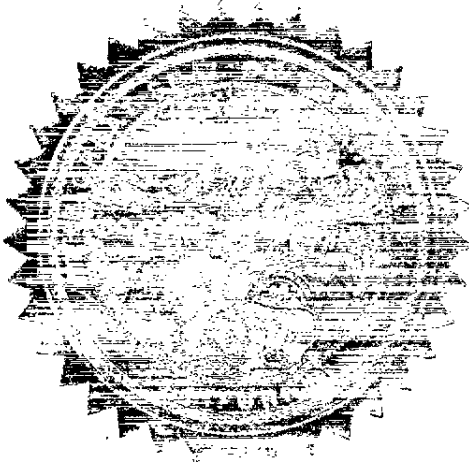
