I contacted the Florida Department of Revenues to determine why they show January 1, 1998 as the initial date of Advanced Data Systems, Inc. transacting business in the State of Florida. They picked that date because I filed a Corporate Income tax statement for the year 1998 which implies 1 January as the start of the tax year. Even though I did not open an office in Florida until September 1998, I had to file a Florida state corporate income tax return because Advanced Data Systems had a small profit that year (as well as 1999) and the Florida Corporate income tax requirements are very explicit, if you exist in Florida, you must file. However, the corporation income and profit in both the 1998 and 1999 tax years were derived on business that occurred in other states, mostly in the State of Maryland. Advanced Data Systems, Inc. has had no earnings in the State of Florida.
