## FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION OF DESOTO BANKING CORPORATION

This First Amendment to the Articles of Incorporation of DeSoto Banking Corporation, a Florida corporation is made and adopted by the Board of Directors of the corporation on this 1744 day of January, 1997.

Be it resolved that the Articles of Incorporation of DeSoto Banking Corporation, originally filed with the Florida Secretary of State on October 2, 1980, as contained in the corporate record books, are hereby amended as follows:

Article III of such Articles of Incorporation is hereby deleted in its entirety, and I. replaced with the following provisions:

## ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue two hundred thousand (200,000) shares of stock to consist of ten thousand (10,000) shares of common voting stock with a par value of \$1.00 per share, and one hundred and ninety-thousand (190,000) shares of common non-voting stock with a par value of \$1,00 per share. Such common voting stock and common non-voting stock shall herein collectively be referred to as "common shares".

It is hereby authorized and agreed that such common voting stock and common nonvoting stock shall consist of only one class of stock with identical rights, duties and obligations; provided, however, that such shares shall maintain their respective voting or non-voting rights, as indicated.

- All other provisions of the original Articles of Incorporation of DeSoto Banking H. Corporation are hereby restated, ratified and confirmed.
- The number of votes cast for this amendment by the shareholders and directors III. of the corporation was sufficient for approval by such shareholders and directors.
