The following Articles of Merger have been adopted as required by Florida Statutes Sections 605.1025 and 607.1105, and in accordance with Florida Statutes Sections 605.1022 and 607.1101(2).

(a). **The name, jurisdiction of formation, and type of entity of each party of the merger:**

Merging Entity: Sims Equipment, LLC, organized in the state of Florida as a limited liability company ("**SEQ**").

Surviving Entity: Sims Crane & Equipment Co., organized in the state of Florida as a corporation ("**SCEC**").

(b). **The surviving entity's articles of incorporation shall not be amended and shall remain as existing prior to the merger.**

(c). **Approval of the Plan of Merger:**

The Plan of Merger was approved by the sole member of SEQ pursuant to Florida Statutes Section 605.1023.
