It is my opinion that outstanding fees and penalties are not actually owed. As a result, I recommend the closure of this file.

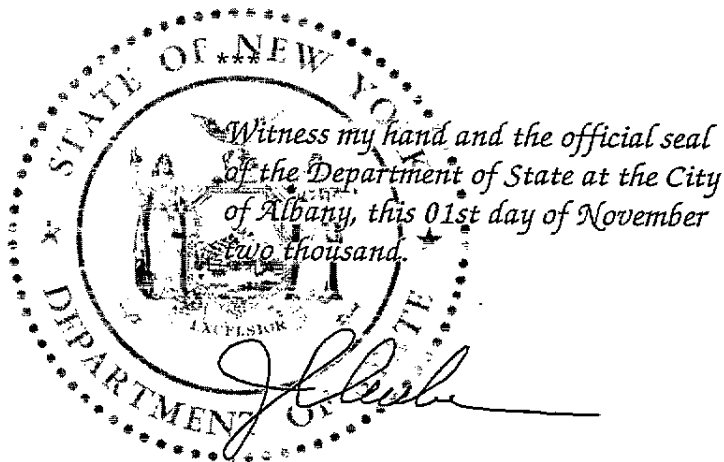
