That on the **16th day of September, 1992**, **KRISHNALOKA** became incorporated under the laws of the State of California by filing its Articles of Incorporation in this office; and

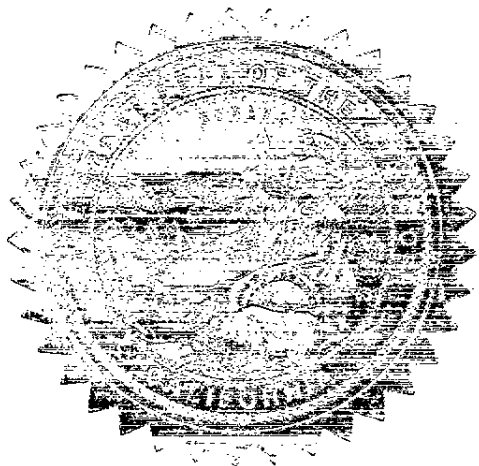
