Re: Application by Banco Commercial Portugues, S.A. for Authority to Open an International Bank Agency Office to be Located in Miami, Miami-Dade County, Florida (Administrative File No. 3951-B-11/00)

The Comperciler of the State of Florida, as head of the Department of Banking and Finance (Department), having fully considered the facts and information contained in the record relating to the application for authority to establish an international bank agency office in Miami, Florida, by Banco Commercial Portugues, S.A. (Applicant), gives notice that the Department intends to approve the application and makes the following:

#### FINDINGS OF FACT

- (1) An application for authority to establish an international agency office, along with applicable filing fee, was submitted to the Department on May 18, 2000.
- (2) Notice of the application was published in the Florida Administrative Weekly on June 2, 2000. No hearing was requested and none was held.
- (3) After its preliminary review, the Department requested additional information from the Applicant on June 12, 2000. The additional information was received by the Department on November 2, 2000, and the application was deemed complete.
- (4) The application states that the proposed office will be located at 201 South Biscayne Boulevard, Miami, Florida.
- (5) On November 3, 2000, the Department requested that its Investigations Office perform background investigations on the following executives of the Applicant: Jorge Manuel Jardim Goncolves, Christopher & Beck, and Pedro Libano Monteiro. No adverse matters were noted.
- (6) Banco Portugues do Atlantico, S.A. (BPA) has operated an international bank agency office in Florida since July 1986. BPA has merged with and into the Applicant at the home country level of operation. Because international bank licenses are not transferable, the Applicant was required to file an application for an international bank agency in order to continue operation of the BPA agency in Florida.
- (7) The Applicant was approved by the Department to establish an international bank representative office in Florida on May 26, 2000.

- (8) Acting under delegated authority, the Federal Reserve Bank of New York approved an application by Banco Commercial Portugues, S.A. for authority to operate an international agency office in Florida on or about July 17, 2000.
- (9) Based on its review of the application, the Department has determined that the Applicant is chartered in a jurisdiction in which any bank having its principal place of business in this state may establish similar facilities or exercise similar powers.
- (10) Based on its review of the application, the Department has determined that the Applicant holds an unfartricked license to receive deposits from the general public in the foreign country under the laws of which it is organized and chartered.
- (11) Based on its review of the application, the Department has determined that the Applicant is adequately supervised by the central bank or bank regulatory agency in its home country.

Having considered the application, the Department concludes that the application satisfies the criteria of Section 663,05, Florida Statutes. Consequently the Department intends to approve this application subject to the following conditions:

- (1) That the Department will issue a conditional Final Order of Approval no earlier than 21 days after the date of this Notice, unless the Applicant advisor the Department, in writing, that it waives its right to a hearing.
- (2) That an Application By Foreign Corporation For Authorization To Transact Business In Fioridz (with original signatures) is provided to the Department along with a check, made payable to the Department of State, for applicable filing fees.
- (3) That the Applicant shall advise the Department at least thirty (30) days in advance of the desired date that the BPA agency will become an agency of Banco Commercial Portugues, S.A. If the Department finds that all requirements of law and this Notice have been met, it shall issue and deliver the license to operate an international office in Florida.

This approval shall expire twelve (12) months from this date if the international office has not been opened, unless an extension of time has been requested by the Applicant and granted by the Department. Until the conditions herein specified, and other reasonable requirements of the Department of Banking and Finance are met, or if any interim development is deemed by the Comptroller to warrant such action, the Comptroller shall have the right to after, suspend, or withdraw this Notice.
