As a follow up to my CPA's, Charles Godels', telephone conversation with you on January 10, 2001, the following is a documented account of the specific nature of the activity of Nothing To Talk About Mariners, Inc.-a Delaware corporation.

I purchased my boat in Nothing To Talk About Mariners, Inc. This corporation was incorporated in the state of Delaware. Your office has a record of the appropriate documents verifying this fact.

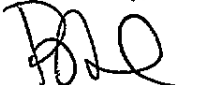
During the latter part of 1999, I was approached to "loan" out the boat. This isolated incident (as defined in F.S. 607.1501) resulted in my receiving minor remuneration. I appropriately reported the remuneration as taxable, and my C.P.A. prepared corporate income tax returns, accordingly. This apparently triggered the foreign corporation doing business in the state of Florida issue.

Once again following instruction, I filed the appropriate forms and paid the related fee. This, in turn, resulted in my being fined \$1,150.00.

Again, pursuant to your teleconference with Charles P. Godels, my C.P.A., this incident, prior to my Corporation's actual qualification, was an exempt "isolated transaction" as defined by F.S. 607.1501.

Please consider this correspondence as the written, notarized affidavit required pursuant to F.S. 607.1501 in order to correct erroneous information as provided on the original application. Thank you again for your assistance and cooperation in resolving this matter.

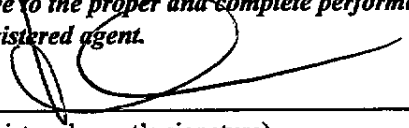
