2000. Sorry for the misunderstanding.

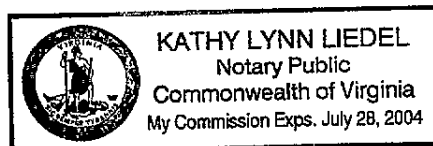
