Exhibit A

The Corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-For-Profit Corporation Law, and is a Type B Corporation as defined in subparagraph (b) of Section 201 of said law and is to be formed for the following purposes:

- (a) to benefit religious, scientific, literary, educational, or other charitable organitions and to further religious, scientific, literary, educational, or other charitable purposes.
- (b) to solicit, request, appeal for, conduct, engage in or assist in campaigns, fund raising drives, and any efforts whatsoever for the collection and raising of monies, funds, donations, pledges, obligations, securities, subscriptions, commitments, gifts, grants, bequests, devises, legacies, chooses in action and property of every nature and description whatsoever, both real, personal, or mixed, and wheresoever situate, whether in the United States or in any other part of the world, and to receive, accept, collect, acquire, and hold title to the same, and to manage, improve, and develop the same in furtherance of the purposes of the Corporation; and, at the discretion of the Board of Directors of the Corporation, to invest and reinvest, manage, sell, mortgage, lease, exchange, convey, or otherwise dispose of or transfer the same in such manner as, in the judgment of the Board of Directors of the Corporation, will best promote the objectives and purposes of the Corporation.
- (c) to use, expend, transfer, deed over, distribute, and disburse all or any part of the monies, funds, and other properties received by the Corporation for the purposes referred to in subdivision (a) hereof in the United States of America and elsewhere, as shall be approved by the Board of Directors of the Corporation in accordance with the provisions of the By-Laws of the Corporation.
- (d) to organize, promote, establish, and create, in any place in the world, through its representatives, appointees, or agents, for effecting the purposes and objectives of the Corporation, agencies, companies, associations, stock or membership, corporations, foundations, trusts or committees and to control, operate, and hold stock, membership or other interests in such entities.

In furtherance of its corporate purposes, the Corporation shall have all general powers enumerated in Section 202 of the Not-For-Frofit Corporation Law, together with the power to solicit, accept and hold contributions, gifts and grants for corporate purposes.

The Corporation shall be organized and operated exclusively for the above purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws, and shall not be operated for pecuniary profit or financial gain.

No part of the property (including income) of the Corporation shall be diverted in any manner directly or indirectly, or otherwise inure to the benefit of any member, trustee, director or 300116.1

officer of the Corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one of its purposes); and no member, trustee, director, officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

No part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating or intervening in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

Nothing herein shall authorize the Corporation, directly or indirectly, to engage in or include among its purposes any of the activities mentioned in the Not-For-Profit Corporation Law, Section 404(b)-(v).
