I am writing in response to your letter dated 11-30-00 regarding our recently submitted "Application by Foreign Corporation for Authorization to Transact Business in Florida".

We have not previously submitted this application because pursuant to section 607.1501 of the Florida Statutes "...if the orders require acceptance outside this state before they become contracts" then those activities "...do not constitute transacting business within the meaning of subsection (1)". All new contracts sold from our Florida office require acceptance and approval by management in our Baltimore, Maryland office before they become contracts. All customer requests for changes and/or service are received and dispatched from our Baltimore, Maryland office. For these reasons, we do not feel that we should be assessed the civil penalties, nor the annual report/uniform business report fees described in paragraph #2 of your letter. We do wish to pursue this authorization, however, so that in the future as we grow in Florida, we can have management and staff in that office to approve and accept contracts and/or work orders.

We would like to adopt the following alternate name for use in the state of Florida: Interconnect Services of Sarasota, Inc. We have enclosed a corporate resolution stating this.
