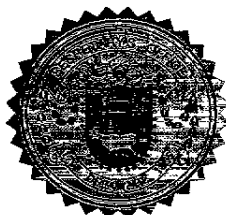

FIRST: That the name of the Corporation is "SCA SALES CORPORATION"

SECOND: That the Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on March 28, 2000.

THIRD: That the Corporation's Certificate of Incorporation is hereby amended by deleting Article FIRST thereof in its entirety and by substituting in lieu thereof the following new Article FIRST:
