Pursuant to section 607.1502(4), 617.1502(4) or 608.502(4), Florida Statutes, this office collects a civil penalty of \$1000 for each year this entity transacted business or conducted its affairs in Florida prior to qualification and the appropriate annual report fees that would have been due this office had the entity qualified the year it began operations in this state. The amount due this office to cover both annual report and penalty fees is \$2300.00.

Enclosed please find a copy of section 607.1501 or 617.1501, Florida Statutes, which lists those activities that do not constitute transacting business in this state. If after reviewing this section you determine erroneous information was inserted on the application, a notarized affidavit containing the following information must be submitted: 1.) a statement indicating erroneous information was listed on the application; and 2.) the correct date the corporation began transacting business in Florida prior to the year the application was submitted did not constitute transacting business pursuant to section 607.1501 or 617.1501, Florida Statutes.

This letter is to follow-up on the above referenced matters with regard to Unicorn Communications, Inc. We have not received any information from past inquiry. As noted previously, this matter has been forwarded to this firm for resolution. It is our understanding that, Unicorn Communications, Inc., an Illinois corporation, previously submitted Application for Authorization to Transact Business in Florida, in late 1999 or early 2000. The application erroneously indicated that the date of first business in Florida was prior to the date of the application.

As the enclosed verified statement of Unicorn Communications, Inc.'s President, David L. Rottmayer, indicates, the company did not transact any business, as that term is defined under Florida law, Section 607.1501, *Fla. Stat.*, in the State of Florida prior to the initial application, nor has it done so to date. In actuality, the corporation is just now preparing to undertake business in the State, and has heretofore, only been the location of residence of the corporation's President.

Accordingly, we are seeking a clarification of the previous inquiry into the status Unicorn Communications, Inc.'s business transactions in Florida, and for approval of the company's current Application for Authorization to Transact Business in Florida, which is enclosed herewith.

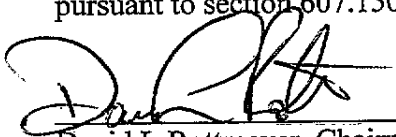

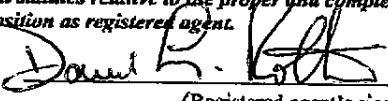

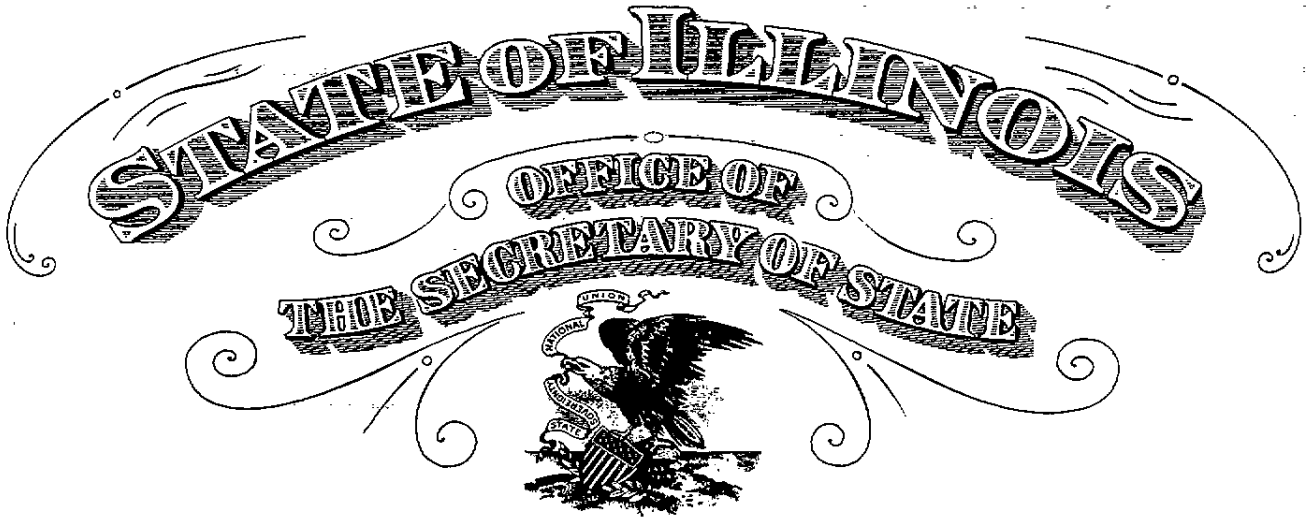
