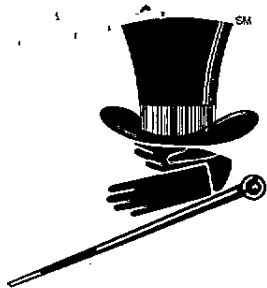

Thank you for receiving my phone call on March 8, 2001. I am enclosing a copy of the letter you sent to our registered agent corporation regarding the penalty for doing business in Florida prior to applying for the "Certificate Authority To Do Business As A Foreign Corporation".


