We received your letter, number 501A00013575, and according to the Florida Statutes, we have not been "transacting business" in the State of Florida. In the application we sent you, we stated that we have been transacting business but this was an erroneous statement as we were only going by our banks definition of "transacting business". We opened a bank account and the bank officer said that we must be registered with the state. I called your office and was told that we did not have to be registered to open a bank account but the bank officer insisted, so we filed for registration.

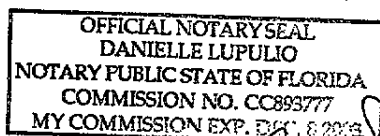

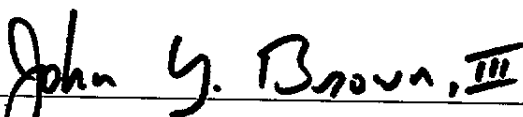
