Dear Sir/Madam:

We have reviewed your correspondence dated October 20, 2000, a copy of which is enclosed, questioning the above referenced company's lack of authority to do business in Florida.

This company appears to be transacting business in Florida within the meaning of s 607.1501, F.S. The "Application by Foreign Corporation for Authorization to Transact Business in Florida" will be forthcoming under separate cover. The company owns and operates a commercial rental property in Miami. This is the only nexus that the company has with the State of Florida.

The company has been voluntarily filing corporate net income tax returns since 1997. It is our understanding that the company is being assessed an annual penalty of \$1,150 retroactive to 1997.

The company inherited this property and was not aware that the appropriate registrations and/or applications to transact business were not done at that time. The company was also not made aware of the lack of registration when it filed its first corporate tax return four years ago. In fact, this is the first notification that the company has received concerning this issue.

As this time, we would like to appeal the assessment of these penalties. The company intends to comply with the registration procedures and would have done so sooner had management been made aware of the problem. Management assumed that the company had been grandfathered under these provisions many years ago.

COMMENTS: This communication will confirm our conversation today regarding annual report fees and statutory penalties which would be assessed against L.E.F.A., Inc., under section 607.1502(4), Florida Statutes.

Information from the Florida Department of Revenue suggests L.E.F.A., Inc., has transacted business in Florida since 1997. Accordingly, an amount of \$3450.00 is due, reflecting annual report fees of \$450.00 and statutory penalties of \$3000.00. We would, however, offer to settle the issue of annual report fees and foreign non-qualified penalties from L.E.F.A., Inc., for the sum of \$1950.00, reflecting annual

report fees from 1997 of \$450.00 and penalties of \$1500.00 assessed at the statutory minimum to avoid litigation. This offer remains in effect until April 23, 2001.

Upon completion of the application and receipt of a check in that amount payable to the Department of State, Division of Corporations, I will instruct the Division of Corporations to issue L.E.F.A., Inc., a Certificate of Authority to transact business in Florida.
