I recently filed an "Application by Foreign Corporation for Authorization to Transact Business In Florida."

Erroneous information was inadvertently listed in Item 6 which asks for the "Date first transacted business in Florida." The date of 1990, which was shown in Item 6, is the year we established a resident sales person in Florida.

We do not, and have not, "transacted business" in Florida by the definition in Section 607.1501 of the Florida Statutes. It states, (2)(e), that "Selling through independent contractors" does <u>not</u> constitute transacting business within the meaning of Subsection (1).

Plato Products, Inc. has one employee, resident in Florida, who works with independent contractors (authorized distributors). These contractors purchase our products from Plato Products, Inc. in California and then re-sell our products to their customers in Florida. We do not own or control these independent contractors, nor do we make direct sales to customers in Florida.

For these reasons, I request that the amount of \$12,826.25, to cover annual report/uniform business report and penalty fees, as indicated in your letter of February 28, 2001 (No. 301A00012439), be rescinded.
