This will serve as notice of a transfer of the tangible property and business operations from FRx Software Corporation, FEIN 84-1277044 ("FRx Old Company") which was merged into a new company which took the same name, FRx Software Corporation, FEIN 84-1551592 ("FRx New Company") after the merger.

FRx Old Company was acquired and experienced an ownership change by way of a tax-free reorganization pursuant to Internal Revenue Code §§368(a)(1)(A) and 368(a)(2). At the close of business on March 19, 2000, FRx Old Company was merged into a newly created company called GPS Acquisition, Inc, which began operations on March 20, 2000. Subsequent to the date of the merger, the name of GPS Acquisition, Inc. was changed to FRx Software Corporation.
