


Thank you for your time discussing the above-referenced client. My client, Terri Mermis, is the sole stockholder in TCyber, Inc. Unfortunately, when Ms. Mermis moved to the State of Florida in 1998, she used a corporation to help her file the necessary documents to do business in the State of Florida. Recently, Ms. Mermis has been applying for an SBA loan and attempted to obtain a certificate of good standing from the State of Florida. As a result of that request, Ms. Mermis learned that the appropriate paperwork for TCyber, Inc. was never filed with the State. As you are aware, this has resulted in a \$3,000.00 penalty being assessed against Ms. Mermis' corporation. Ms. Mermis is unable to pay this large penalty, and is in desperate need of obtaining a certificate of good standing so she can proceed forward with her SBA application.

Ms. Mermis understands that she will be required to pay \$450.00 (representing the \$150.00 annual report fee that would have been paid to the State of Florida had she properly registered her corporation in 1998). Ms. Mermis' gross income for her corporation in the year 2000 was \$45,308.00. As you can see, paying a \$3,000.00 fine would be a severe hardship.

We would greatly appreciate if the State of Florida would waive the penalty portion of the outstanding fees so that Ms. Mermis will be able to do the proper filings with the State and obtain a certificate of good standing.

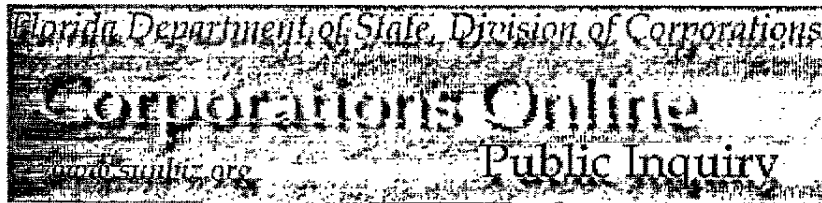


