Thank you for your time discussing the above-referenced client. My client, Terri Mermis, is the sole stockholder in TCyber, Inc. Unfortunately, when Ms. Mermis moved to the State of Florida in 1998, she used a corporation to help her file the necessary documents to do business in the State of Florida. Recently, Ms. Mermis has been applying for an SBA loan and attempted to obtain a certificate of good standing from the State of Florida. As a result of that request, Ms. Mermis learned that the appropriate paperwork for TCyber, Inc. was never filed with the State. As you are aware, this has resulted in a \$3,000.00 penalty being assessed against Ms. Mermis' corporation. Ms. Mermis is unable to pay this large penalty, and is in desperate need of obtaining a certificate of good standing so she can proceed forward with her SBA application.

Ms. Mermis understands that she will be required to pay \$450.00 (representing the \$150.00 annual report fee that would have been paid to the State of Florida had she properly registered her corporation in 1998). 


