Please accept this letter as a request to abate the penalty of \$2300.00 referenced in letter number 900A00063151 from Michelle Hodges dated December 15, 2000. American Incorporators Limited is the registered agent in the State of Delaware for Practically Pikasso. Robert Webb acquired a Sales and Use Tax ID along with the Florida Unemployment Compensation forms in October of 1999. Mr. Webb also spoke with a representative at the Florida Department of Revenue Arbor Shoreline Office located at 19337 US Highway 19 N, Suite 200, Clearwater, FL 33764 in October and November of 1999. This representative assured Mr. Webb that he had met all State and Federal requirements to open a company. The first transaction completed at Practically Pikasso was not until November 1999 once the paperwork had been completed. Practically Pikasso was notified in the last Quarter of 2000 that they had not "Applied for Authority to Transact Business in Florida." Mr. Webb immediately completed the application and forwarded proof of incorporation along with a check for \$78.75 to the Florida Department of State.

Please accept this letter as evidence that Practically Pikasso made every effort to complete and submit all paperwork necessary for operating a business in Florida. If this form was made known to Practically Pikasso I assure you that it would have been submitted prior to transacting business. Please abate this penalty.






