This letter is in response to your letter of March 19, 2000, numbered 301A00016489, regarding the assessment of a civil penalty of \$1,000 for each year our company has transacted business in Florida. There appears to be some confusion in reconciling the information on our application with your records.

On September 10, 1998 ViewSonic Corporation merged into VWS Corporation, a Delaware corporation. Thereafter, VWS effected a name change to ViewSonic Corporation and the California corporation was dissolved.

It is our understanding that the procedure for amending our information with your office requires ViewSonic to submit an Application for Withdrawal and file a new application reflecting the amended information. Accordingly, ViewSonic submitted, and was granted, a withdrawal on March 19, 2001. The date that ViewSonic began transacting business in the State of Florida is correct as stated on the application as April 17, 1997. ViewSonic was properly registered as of that date. Therefore, ViewSonic believes that the civil penalty you imposed is inappropriate. Enclosed, for your reference, is the letter granting the withdrawal and a certificate from your office indicating that ViewSonic was authorized to transact business in your state as of April 17, 1997.


