J.T. Almon, President of Rep Services Inc., also acting as Basics Inc.s Registered Agent, contacted me about an apparent error in Basics Incs.' Application by Foreign Corporation for Authorization to Transact Business in Florida. During my preparation of the application I used the incorrect date for number 6, "Date first transacted business in Florida." I used the Registration Effective Date from the 2001 Florida Annual Resale Certificate for Sales Tax.

Unfortunately I had not read Section 607.1501 which clearly states the activities that do not constitute transacting business within the state and therefore, a certificate of authority from the Department of State is not required. Basics Inc. sells it products through an independent contractor, Rep Services Inc., which falls under Section 607.1501 (2)(e). In addition, acceptance of any orders takes place at our office in Delano, MN, which falls under 607.1501 (2)(f). Consequently, Basics Inc's Florida activities do not constitute transacting business as defined in Section 607.1501 (1).


