1. That a notice of the meeting of the Members of "Through Faith Finding Hope Ministries" to determine whether such church should become incorporated was duly given in pursuance of Section 191 of the Religious Corporations Law, and such meeting was held in accordance therewith on the 12th of July 1998, at 4:00 o'clock in the afternoon of that day.

5. The principal place of worship of such corporation is to be located in the County of Erie, City of Buffalo, State of New York, and at P.O. Box 352.


6. The Minister decided upon at such meeting is Minister Weldon Walker, Jr.


7. The number of trustees decided upon at such meeting was seven (7) with the Minister, Weldon Walker, Jr, ex officio member thereof.


9. The date fixed by such meeting for holding the first annual election of the trustees of such corporation was the 3rd day of October, 1998.
