

COMMENTS: This communication is in response to your letter dated April 10, 2001 and our conversation today regarding annual report fees and statutory penalties which would be assessed against Sunstates Maintenance Corporation under section 607.1502(4), Florida Statutes.

You have indicated Sunstates Maintenance Corporation has transacted business in Florida since 2000. Accordingly, an amount of \$1150.00 is due, reflecting annual report fees of \$150.00 and statutory penalties of \$1000.00.
