As the President of Perfito Management, Inc., General Partner of NVCP Limited Partnership. I respectfully submit this request for an abatement of any and all penalties associated with this late filing for Perfito Management, Inc. per your letter dated, April 11, 2001 to my attorneys at Weatherby & Associates, PC (See attached copy of letter).

Upon creation of both Perfito Management, Inc. and NVCP Limited Partnership by my Connecticut Attorneys there was some apparent miscommunication between them and my accountant, Jim Schulz of Sheptoff, Reuber & Co., 111 New London Turnpike, Glatonbury, CT 06033, as to who was going to register the entities as doing business in Florida (i.e. each thought the other was going to handle that duty). During the period of non-registration in question, I arranged for several loans for my companies from corporate lenders through my Florida Attorney Paul Palmer of 12790 South Dixie Highway, Miami, Florida 33158. Non-registration in Florida was never raised by the corporate lender nor my attorney as an obstacle to the first transaction, nor any subsequent transactions. While I was transacting business at that time on behalf of my companies, since it never came up, I thought registration had already been handled. Had I known about the fact that both Perfito Management, Inc. and NVCP Limited Partnership were not registered with the state of Florida, I would have corrected this oversight, since I was filing tax returns during that period under the assumption that my companies were registered in Florida. Other than the several loan transactions referenced above, the two entities are generally non-transactional in nature, so the fact that neither were registered as doing business in Florida did not come to my attention until a letter was sent from the Florida Department of State, Division of Corporations to Jim Schulz, dated October 20, 2000.

My attorneys were notified via fax in January and a request for a Certificate of Good Standing was submitted to the Connecticut Secretary of State for the two entities on February 16, 2001 (See attached copy of letter), prior to sending the registration paperwork. The registration paperwork was then sent to my registered agent, Edward Easton for his signature on March 16, 2001 (See attached copy of letter). These were subsequently mailed to you on March 29, 2001 (See attached copy of letter).

I, N.V.C. Perfito, also known as Nicholas Perfito, the President of Perfito Management, Inc., General Partner of NVCP Limited Partnership, attest that all of the information in this abatement request is true and accurate to the best of my knowledge and is the basis upon which I respectfully request that any and all penalties be waived.
