Dear Mr. Mays:

I am writing to correct a misunderstanding between your Department and our elient, Huff Thomas & Company. In April of this year, Huff Thomas applied to your Department for authority to transact business in Florida. In that application, they indicated that they had been transacting business in Florida since 1998. While they did enter into a contract with a Florida organization in 1998, it was an isolated contract that did not rise to the level of "transacting business" within the state of Florida.

In 1999, Huff Thomas again obtained an unexpected contract which originated in Florida. Notwithstanding the fact that they had completed a contract in 1998, the 1999 contract was also an isolated transaction to the extent that Huff Thomas did not anticipate doing any more business in Florida, they were not pursuing any business in Florida, and this contract had only been the second contract they had entered into in Florida in their 4 years of operation.

In 2000, Huff Thomas did not conduct any business in Florida. At some time toward the beginning of 2001, they contemplated conducting future business in Florida. At that time, they decided to apply for authority to transact business in Florida. Because they had engaged in a contract in Florida in 1998, they stated in their application that they had been transacting business in Florida since 1998.

In your response to that application, you stated that the Department assessed a penalty fee of \$3,450 on the basis that Huff Thomas had been transacting business in Florida since 1998 without authority. As I am sure you have noted from these facts, Huff Thomas has not "transacted business" in prior years to the extent that would have required them to apply for authority to transact business in Florida.

As a result, we are respectfully requesting to have our original application amended to state that the transaction of business in Florida did not begin until 2001 and, coincidental to that amendment, to have the penalty fee waived.
