BEFORE ME, the undersigned authority, personally appeared JOSEPH H. LOWE, ESQUIRE, who, after being duly sworn, deposes and states:

- 1. I am a member of the Florida Bar and have for the last twenty (20) years represented Air Jamaica, Ltd.
- 2. Air Jamaica, Ltd., is a corporation incorporated under the law of Jamaica engaged in operating an international airline.
- 3. Pursuant to treaties between Jamaica and the United States government, Air Jamaica is authorized to maintain offices in various locations throughout the United States for the purposes of interstate commerce. Air Jamaica flies into a number of cities in Florida.
- 4. On or about November 28, 1998, Air Jamaica sold aircraft repair equipment located in Jamaica to a Florida corporation and made arrangement to transport same from Jamaica to Florida. The purchaser of equipment has

- failed to pay the contract price necessitating Air Jamaica to file suit in Broward County Circuit Court to recover the equipment and for damages.
- 5. The purchaser in defending the lawsuit has claimed that inasmuch as Air Jamaica, Ltd., maintains an office and has a physical presence in the State, it is obligated to register pursuant to Florida Statute \$ 607.1502. The circuit court judge has stayed the lawsuit until such time as Air Jamaica registers with the State of Florida.
- 6. Air Jamaica contends that pursuant to Florida Statutes \$ 607.1501(2)(i) it does not transact business in the State of Florida requiring it to register. However, in order to maintain its lawsuit, it is registering with the State.
- 7. The date of November 28, 1998, appearing on item 6 of the application represents the date of the contract sale and not the date Air Jamaica first transacted business in Florida as defined by the Florida Statutes.
