Please re-instate the "JJC & LM, Inc." to its "non-active" and answer before 4/20/2005.

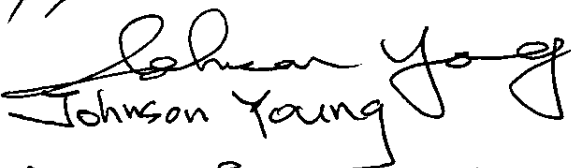
