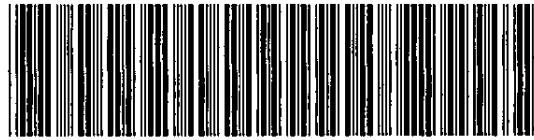

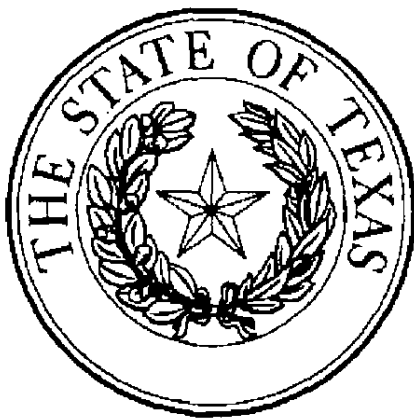

The name of the corporation is: **Association for Consumer Awareness, Inc.**


Article I of the Articles of Incorporation duly filed in the State of Texas on May 14, 1992 is hereby amended to read as follows:
