I would like to request that you forward this letter to the General Counsel for review. I am requesting that HealthScribe, Inc. be considered for a waiver of the penalties that are currently being assessed to our company. I have enclosed a copy of your letter dated April 23, 2001. We are being assessed \$4,000 in penalties and \$600 for annual report fees.

HealthScribe, Inc. was incorporated in the state of Delaware in June of 1993. In June of 1999, there was a change in management within the corporation, which included a new CEO and CFO/COO as well as other management level positions. Since June of 1999 HealthScribe's new management has gone through the process of reorganizing all aspects of the corporation.

At this time we are going through a voluntary compliance effort to ensure that we are properly registered to conduct business in all states where we have or have had customers. While completing the application for Florida we found that HealthScribe, Inc. did conduct a minor amount (approx. \$10,000 revenue) of business in Florida from August 1997 to October 1997. HealthScribe then resumed conducting business in Florida as of April 1999 and is currently conducting business with customers in Florida.

Since HealthScribe is going through this compliance effort, at this time we would like to be considered for a waiver of the penalties that were assessed to our company. The \$4,600 is due to Florida no later than June 23, 2001. Please let us know if that date will be extended while our case is being reviewed.


