



Dear Attorney General,

As a small family business in the state of Connecticut the civil penalty you have assessed is not consistent with our intent or actions in Florida. Since we began business we have filed and paid the appropriate State Income Tax and remitted unemployment taxes. We have not attempted to escape any lawful taxes or fees and apologize for not knowing we needed to qualify in your state.

I can assure you the annual filing fee cost is very reasonable and certainly not something we would intentionally ignore. The \$3,000 civil penalty is a significant amount for our company and since we only pay the minimum income tax of \$800 each year it seems excessive.

We recognize our responsibility to pay the past filing fees, including interest, but respectfully ask you to consider waiving the civil penalty and accepting our filing.


