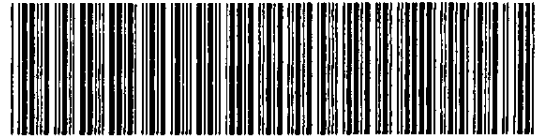

NAME


The name of the corporation is nGenera CIM Corp."
