Thank you for sending the Corporation Act booklet. I have reviewed section 607.1502, but was not able to determine the contents of section 617.1502(4) or 608.502(4) since those statutes were not listed in this booklet.

Colonial Seal Company acquired the stock and assets of Advanced Seal Technologies in January 2000. Advanced Seal Technologies is a Florida corporation that was incorporated on 7/31/1995. The taxpaver ID # is 65 0596730. According to section 607.1501(2) (k):

- "(2) The following activities, among others, do not constitute transacting business within the meaning of section (1):
  - (k) Owning and controlling a subsidiary corporation incorporated in or transacting business within this state or voting the stock of any corporation which it has lawfully acquired."

Since we continue to do business under both Colonial Seal Company and Advanced Seal Technologies, and we filed Form 8869 as a Qualified Subchapter S Subsidiary Election this year, we therefore request reconsideration on the contents of letter # 501A00033197. Colonial Seal was formerly located in NJ, and has moved its operation to FL during the past year. Shipments to customers are conducted both in FL and in NJ. On the advice of our accountant, he suggested that we go through the process of registering Colonial Seal Company as a foreign corporation.






