AMENDMENT TO THE ARTICLES OF INCORPORATION DOCKET NO. R-01-0812

General remarks and official action taken:

On this day came on for consideration by the Commissioner of Insurance, the application of UNIFIED LIFE INSURANCE COMPANY OF TEXAS, Austin, Texas, for approval of an amendment to the Articles of Incorporation changing its name from UNIFIED LIFE INSURANCE COMPANY OF TEXAS to UNIFIED LIFE INSURANCE COMPANY and for a Certificate of Authority evidencing such change. Since the amendment to the Articles of Incorporation involves only a change of name, a hearing is not required by law.

Action by UNIFIED LIFE INSURANCE COMPANY OF TEXAS as required and permitted by TEX. INS. CODE ANN. art. 1.14 and art. 3.05, has been evidenced to the Commissioner of Insurance. The amendment is properly supported by the required documents, which evidence that the name UNIFIED LIFE INSURANCE COMPANY, is not so similar to that of any other insurance company as to be likely to mislead the public. The name change endorsement for UNIFIED LIFE INSURANCE COMPANY, Austin, Texas, Form No. ULICTX-NCE-9-01 has been filed with the Life/Health Division of the Texas Department of Insurance.

Based upon the evidence submitted, it is hereby ORDERED by Commissioner of Insurance, that such amendment be, and the same is hereby, approved. It is further ORDERED that a Certificate of Authority be issued to UNIFIED LIFE INSURANCE COMPANY, Austin, Texas, evidencing the change effected by the amendment and that thereupon the prior Certificate of Authority No. 12839, dated May 15, 2001, be canceled.

ARTICLES OF AMENDMENT TO THE

ARTICLES OF INCORPORATION OF

UNIFIED LIFE INSURANCE COMPANY OF TEXAS

Pursuant to the provisions of Part 4 of the Texas Business Corporation Act, and Article 3.05 of the Texas Insurance Code, the undersigned corporation adopts the following articles of amendment to its articles of incorporation and charter.

ARTICLE ONE

The name of the corporation is Unified Life Insurance Company of Texas.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on July 18, 2001. The Articles of Incorporation are amended to change the name of the corporation to UNIFIED LIFE INSURANCE COMPANY. The amendment changes only Article II of the Articles of Incorporation, as approved by Official Order 01-0441 of the Commissioner of Insurance of the State of Texas, without changing any other article. The full text of that provision as altered is as follows:

"ARTICLE II

The name of the corporation is UNIFIED LIFE INSURANCE COMPANY."

ARTICLE THREE

The number of shares of the corporation issued and outstanding at the time of the adoption of the amendment was 25,000; and the number of shares entitled to vote thereon was 25,000.

ARTICLE FOUR

The holders of all of the shares outstanding and entitled to vote on the amendment have voted in favor of the amendment and have signed a consent in writing adopting said amendment.

ARTICLE FIVE

The corporations's name change will not increase or decrease its capital or surplus.

In conformity with the above, I, Frank M. Neidig, President of the corporation, have executed this instrument, and I do hereby sign and acknowledge the same for and on behalf of the corporation this 18th day of July, 2001.
