- 5) To provide educational related services for infant school age children, youth and adults.

## **OBJECTIVES**

- A) To provide affordable housing for low and moderate income families; persons with AIDS; homeless persons; physical challenged persons; the Elderly and homeless Veterans.
- B) To provide counseling to persons, including welfare recipients with AIDS, Drugs and alcohol related problems; Home-care; referrals to other agencies; Volunteer ambulance services; Screening for persons without health insurance and to be able to form an HMO.
- C) To assist persons in obtaining legal status and to be come citizens of the U.S.A. To provide counseling and representation at the Immigration and Naturalization of Service office.
- D) To operate and maintain facilities which offer educational training, and after school tutorial programs for infants, school age children, youth and adults including seniors. Such training would include computer and other related services.
