We are responding on behalf of the above referenced taxpayer to your letter dated May 15, 2001. A copy of the letter is enclosed for your reference. Pursuant to the letter, \$2,300 is due in penalty fees and annual report/uniform business report fees due to transaction of business in Florida prior to qualification.

The taxpayer is a U.S. holding company which owns a 25% interest in the Freudenberg-NOK General Partnership (FNGP). FNGP began business in Florida in September 1999. The taxpayer was not made aware of this until March 2000 when it obtained information from FNGP for purposes of extension filings. Since the taxpayer does not directly conduct business in Florida, they did not know of the registration requirements in Florida. The taxpayer, along with the other partner in FNGP, is now trying to comply with such requirements. Based on the taxpayer's lack of direct contact with the State of Florida and delay in notification of Florida activity, we respectfully request abatement of the penalties for transaction of business prior to qualification. It was not the taxpayer's intention to try to Encumber any registration requirements.




